^{*} To be eligible for financial support, SMEs must:

- Have state registration and engage in **priority business activities in Chelyabinskaya** Oblast;

- Have no overdue debts related to budgetary funds provided on repayable basis, or overdue taxes payable to the budgets of all levels and to public extra-budgetary funds;
- Ensure that all permanent jobs are occupied as at the date of subsidy application and maintain the same number of jobs in the current fiscal year and/or create new permanent jobs;
- Ensure an increased or the same amount of tax deductions to the budgets of all levels in the current fiscal year;
- Ensure an average monthly pay of SME employees no lower than the subsistence level defined for able-bodied population in Chelyabinskaya Oblast.

Subsidies may not exceed the projected annual tax deductions to the budgets of all levels and to public extra-budgetary funds.

In Chelyabinskaya Oblast, priority business activities eligible for financial support include:

- 1) Manufacturing industries (except for excise goods);
- 2) Handicrafts;
- 3) Innovative activities;
- 4) Agriculture, fishery, fish farming;
- 5) Healthcare (medical treatment institutions, medical practice, veterinary medicine, other healthcare activities), education and social services;
- 6) Domestic, inbound tourism
