1. General Notes

- 1.1. The present Schedule stipulates fees and commissions (hereinafter referred to as "commissions") charged by Vnesheconombank for transactions executed at the request of private customers (except for businessmen who do not constitute juridical entities), hereinafter referred to as "Customers".
 - The list of services included in the Schedule, rates of commissions and terms of charging thereof are determined (amended/supplemented) by Vnesheconombank unilaterally with the exception of services marked "commission rate is subject to an arrangement".
 - The Schedule may be changed or supplemented by Vnesheconombank under prior notification to the Customers.
- 1.2. In accordance with Article 21 of Federal Law of May, 17, 2007 № 82-FZ «On Bank for Development»:
 - Vnesheconombank shall exercise functions related to servicing bank deposits and operation of bank accounts of individuals (natural persons) in the event such deposits and accounts were made/opened with the Bank for Foreign Economic Affairs of the USSR prior to its reorganization;
 - Vnesheconombank shall not be entitled to attract funds of individuals in the form of deposits or credit additional funds to the accounts of individuals that have a bank account (deposit) agreement signed, except for interest accrued under such bank account (deposit) agreement. Additional funds, except for interest accrued under a bank account (deposit) agreement, shall be refundable to individuals from which a cash letter was received.
- 1.3. Unless otherwise instructed, fees and other charges shall be borne by the Ordering Party. If a Customer's instruction stipulates that charges are to be borne by the Beneficiary, the fees and commissions payable may be deducted from the payment amount.
 - Fees and commissions of other Banks performing Customer orders apart from Vnesheconombank shall be charged at their actual cost to the Ordering Party or to its Contractor.
 - If fees and commissions are to be borne by a third party, but cannot be recovered in due time owing to the reasons out of control of Vnesheconombank, these fees and commissions shall be charged to the Ordering Party.
- 1.4. Fees and commissions for transactions effected in a foreign currency shall be charged in any freely convertible currency (in conformity with foreign exchange regulations of the Russian Federation) or in the currency of the Russian Federation at the Bank of Russia's exchange rate effective for the date of charging such fees and expenses. Fees and commissions due under transactions effected in Russian Roubles are charged in the currency of the Russian Federation.
- 1.5. No commission shall be charged for:
 - payments to budgets of all levels as well as state off-budget funds;
 - donations to charity and non-commercial organisations;
 - donations and material aid to individuals.
- 1.6. Postages and telecommunication expenses shall be charged in addition to the fees and commissions stipulated by the present Schedule.
