#### 1. General Notes

1.1. The present Schedule stipulates fees and commissions (hereinafter referred to as "commissions") charged by Vnesheconombank for transactions executed at the request of customers-legal entities (except for correspondent banks and other lending agencies) as well as individual entrepreneurs, hereinafter referred to as "Customers". The list of services included in the Schedule, rates of commissions and terms of charging thereof are determined (amended/supplemented) by Vnesheconombank unilaterally with the exception of services marked "commission rate is subject to an arrangement".

The Schedule may be changed or supplemented by Vnesheconombank under prior notification to the Customers.

- 1.2. The services listed in Clause 2.1 are provided by Vnesheconombank to legal entities participating in the implementation of Vnesheconombank's projects, legal entities with accounts opened for them by decision of management bodies of Vnesheconombank in accordance with the provisions of corporate regulatory documents of Vnesheconombank as well as within the framework of Vnesheconombank's performing its agency function.
  - Services listed in Clauses 3.8 of the Schedule are provided to Customers participating in the implementation of Vnesheconombank's projects. Services listed in Clauses 7.1.1, 7.1.3, 7.2.1 (in respect of issuing guarantees) are provided to Customers participating in the implementation of Vnesheconombank's projects.
- 1.3. Unless otherwise instructed, commissions and other charges shall be borne by the Ordering Party. If a Customer's instruction stipulates that charges are for the Beneficiary's account, the commissions and costs payable shall be deducted from the payment amount.
  - Regardless of the original terms and conditions of a Letter of Credit, commissions due under Clause 6.2 are drawn from the Applicant at the time of issuance or amendment of an L/C or can be paid in advance. If L/C terms and conditions provide for passing charges for the beneficiary's account, Vnesheconombank will return the commissions indemnified by the beneficiary to the Applicant.

Commissions and costs of other Banks performing Customer orders apart from Vnesheconombank shall be borne at their actual cost by the Ordering Party or by its Contractor.

If instructed by a Customer that commissions and costs are to be borne by a third party, and if they are not received in due time owing to the reasons out of control of Vnesheconombank, these commissions and costs shall be borne by the Ordering Party.

- 1.4. Commissions and costs of Vnesheconombank for transactions effected in a foreign currency shall be charged either in a freely convertible currency (in conformity with the current foreign exchange regulations of the Russian Federation), or in the currency of the Russian Federation at the Bank of Russia's exchange rate effective for the date of charging such commissions and costs. Commissions and costs due under transactions effected in Russian Roubles are charged in the currency of the Russian Federation.
- 1.5. No commission shall be charged for the services rendered under specific bank accounts to be opened for major contractors or defence contractors in compliance with Federal Law No.275-FZ dd. 29.12.2012 On State Defence Order, in particular, for any transactions effected on the said accounts. Major contractors and defence contractors shall reimburse neither the expenses incurred by Vnesheconombank or any third parties in executing the major contractors or defence contractors' orders under such accounts, nor the postage or telecommunication expenses associated with transactions on such accounts.
- 1.6. No commission shall be charged for:
  - payments to the budgets of all levels as well as state off-budget funds;
  - donations to charity and non-commercial organisations;
  - donations and material aid to individuals.
- 1.7. Postage and telecommunication expenses shall be charged in addition to the commissions stipulated hereby (unless expressly stated otherwise).
